SCHOLARSHIP PURPOSE, ELIGIBILITY and REQUIREMENTS for 2010

Purpose - to grant a scholarship to a qualified applicant who is pursuing full-time undergraduate or technical training at a full-time, recognized institution.

Eligibility -

Children or Grandchildren of a Marine Corps League or MCL Auxiliary member in good standing.

Definitions -

New Applicant - the applicant has never been awarded a scholarship from the Department of Connecticut Marine Corps League.

Renewal Applicant - the applicant is a prior recipient of a scholarship from the Department of Connecticut Marine Corps League.

APPLICATION ATTACHMENTS AND TIMELINE:

- 1. The application must be postmarked no later than 4 June 2010.
- 2. The applicant must provide proof of enrollment.
- 3. The applicant must attach a transcript of her/his grades
- 4. The applicant may attach a résumé.

- 3. If the applicant's sponsor is the Commandant/President of the Detachment/Unit, the Detachment Senior Vice Commandant or Unit Senior Vice President must approve and sign the eligibility requirement.
- 4. The Detachment Commandant/Paymaster or the Unit President/Treasurer must ensure that the sponsor is eligible.
